THE KENSINGTON DAY OF GARAGE SALES

The garage sales and stalls benefited from the advertising provided by the Kensington Residents' Association to attract buyers to the area. The day was a great success and expressions of interest will be sought in the new year as to whether the event should be held in 2016.

UPDATE ON THE URBAN CORRIDOR DEVELOPMENT PLAN AMENDMENT

Recent newsletters have mentioned plans to rezone parts of Kensington along The Parade to allow up to five storey development. The government has consulted with Council on an initial draft Urban Corridor Development Plan Amendment (DPA). The DPA would not rezone areas but would permit five storeys for the Peregrine site and three or four storeys for the Mixed Use Historic Conservation Zone (HCZ) sites depending upon site area(<1500m² – 3 storeys, >1500m² – 4 storeys).

At Council's recent Strategic Planning & Development Policy Committee meeting, there was unanimous and very strong opposition to the proposed DPA and the approach taken by the Minister.

Some of the concerns were:

- Developments would be too high and too dense and would not interface well with adjoining areas.
- Government is intent on ignoring good planning principles, development will be at any cost, "trashing" existing residential areas.
- Strategic deficiency to have linear development along roads and bus routes and not in-line with the 30 Year
 Plan that suggests development around hubs and services.
- No proper community consultation by Government proposed, being left to councils to notify its constituents although not Council's DPA.
- There has been no opportunity to gauge the effect of earlier planning reforms and the Stage 1 uplift DPAs.
- The Minister of Planning has failed to keep his promise that character and historic conservation zones would be protected after adoption of the recent DPAs.
- New policy will water down the requirement to restrict development to a 30 degree envelope from the boundary of adjacent properties, causing overshadowing and overlooking, and blocking solar access.
- Proposed developments adjacent to, and in historic conservation zones, are against all that Council has been trying to achieve. They will destroy character areas and the entries to character areas.

Council resolved to advise the Minister and Department that it does not support the preliminary draft DPA in its current form and requests additional investigations and policy amendments be undertaken, before the draft DPA is released for public and Agency consultation. It also resolved to undertake its own notification of residents and ratepayers concerning the DPA.

It is anticipated that the draft DPA will be released for public consultation in November. It is imperative that residents oppose the DPA as strongly as possible and that opposition is expressed at the political level.

KRA will keep residents informed on developments and any action that is to be taken to oppose the DPA. If you aren't currently on the Association's email list please let us know and your email address will be added to our confidential list.

DID YOU KNOW?
