

### HELICOPTERS LANDING IN KENSINGTON

Peregrine have applied for permission to include a helicopter landing facility on the top of their high-rise development on the corner or Portrush Rd and The Parade in Kensington.

What do we know about commercial helipads on top of high-rise buildings? Paris doesn't have any. It has two helipads both in open fields. London doesn't have any. They have a helipad on the river Thames. Sydney doesn't have any. They currently have a proposal to put a floating helipad on the harbor waters. Melbourne - Ansett had a commercial helipad on their roof in Swanson street in the 1960's but were later stopped from using it because of noise and risk. It now has a floating helipad on the river. New York had a heliport on the Pan Am building in the 60's but after an horrific accident with loss of 5 lives was shut down. It now has helipads on the river.

### PEREGRINE HELIPAD PROPOSAL

In January the Peregrine Corporation applied for a variation to their office tower development in Kensington to include a Helicopter Landing Facility on the rooftop (on the corner of Portrush Road, The Parade and High Street, Kensington). The first step in this application process was the publication of 'Guidelines for the preparation of a Public Environment Report' by the State Planning Commission. This document sets the level of assessment and provides guidelines for the use of the helipad. The next step is for the proponent (Peregrine) to prepare an 'Assessment Document' for which there will be public consultation. Three types of helicopters are proposed to be used, including a BELL 206, EC130 and AW109/H109 for 6-7 passengers. If you want to have a look at the guidelines, they are available at the Council office. The KRA will keep you posted on the public consultation process. ### STAND UP FOR OUR HERITAGE SYSTEM!

The State Government is continuing to implement the new planning system at a lighting pace, which may see the undermining of our heritage protection system. The most pressing issue is the fact that our Contributory Items in Kensington may be at risk of losing their demolition controls. Historic Conservations Zones, such as Kensington where Contributory Items are located, are also at risk.

The new planning system is silent on the protection of both of these, even though they underpin our heritage protection system. The only people who are likely to have been lobbying for the removal of Contributory Items from the planning system would be lobby groups who represent developers and volume home building companies whose 'modus operandi' is building new homes, not renovating old ones.

To demonstrate this, in its submission to the Parliamentary Committee Enquiry into Heritage in September 2018, the Urban Development Institute of Australia proposed that "the Planning and Design Code should remove all reference to Contributory Items (both existing and in the future)". Similarly, the Property Council proposed that "all existing listing to be reviewed".

Many of us acknowledged that the current system of heritage protection is not perfect — but we must not let Contributory Items be demolished before a better system is in place. If you want to protect the beautiful heritage of Kensington, write to our local Members of Parliament requesting that the protection of Contributory Items and Historic Conservation Zones be maintained in the new planning system.
