HOW THE NEW PLANNING CODE AFFECTS YOU

Saying goodbye to our heritage?

Changes to the State's planning laws already mean the loss of community appeal rights. Now with the release of the draft planning code, we have grave fears heritage protection will be further diminished. We have been trying to decipher recent proposed changes and here are our findings to date:

- Kensington will lose the listing of all its contributory items that, as a collection, make up the character and streetscape of our Historic Conservation Zone.
- The proposed controls around the protection of heritage and demolition controls are vague and poorly developed. As an example, demolition tests suggest that a building can be demolished if the 'facade does not contribute to the historic character of the streetscape'. A highly subjective assessment.
- Right now, lack of detail in the Code means it's impossible to know what type of new buildings will be allowed to be constructed.
- Some zones will have a new building height policy that allows for much taller buildings. This risks a loss of amenity and privacy for adjacent dwellings. And 'significant development sites' get a 30% height bonus!

PEREGRINE DEVELOPMENT UPDATES

The development has been a divisive issue and the introduction of the proposed helipad has raised this project back into the public arena. We have received a number of concerns from residents including; worries about excessive noise; concerns over safety and helicopters operating in residential areas; the potential for damage to adjacent buildings; compromises to amenity and the risk that increased usage beyond the proposed 10 days will be sought in the future.

We have been undertaking our own research and here is what we know:

- The Civil Aviation Safety Authority (CASA) does not give approval for helipads.
- Peregrine is required to prepare a Public Environmental Report (PER) in accordance with a set of Guidelines, established by the State Planning Commission.
- Once the PER has been prepared, the next step is consultation with government agencies, local Council, as well as a period of public notification.

We have also met with Peregrine themselves to discuss the proposal and this is what we have been told:

- Peregrine remains "committed to maintaining open lines of communication with our neighbours in Kensington to ensure everyone is kept well-informed."
- They expect that the PER will soon be released by the Minister for public consultation for a period of 30 business days.
- Once the PER is released for public consultation, they will hold a public forum to respond to any questions or concerns.
- Peregrine does not wish to use the proposed helipad for more than 10 days a year and would require special licencing to do so (similar to a commercial airport).

It feels as though there will be a great deal more information available in the near future, so stay posted.
