## DON'T RUBBISH KENSINGTON

Dumping unwanted items on verges, in gutters or parks, or on vacant land is illegal and there's no need to do it! Households in Kensington are entitled to two free hard waste collections per year. You can book collection of 2 cubic metres of hard rubbish (2m long x 1m high x 1m wide) online at [www.eastwaste.com.au](http://www.eastwaste.com.au) or EastWaste on ☎ 8347 5111.

Collection of mattresses or bed ensembles must be booked separately. You may need to book 3-4 weeks in advance for hard rubbish and 1-2 weeks in advance for mattress/bed collection so plan ahead if you know you'll be having a clean-up.

Our local council's website lists options (many free of charge) for disposing of electronic or e-waste, household chemicals, paint, just about anything you can think of ([www.npsp.sa.gov.au](http://www.npsp.sa.gov.au))

If it's too good to waste, don't leave your cast offs on the footpath and hope someone takes a shine to it! Donate to charity – some charities will collect furniture and household items at no cost to you. Or advertise your goods for free collection with Facebook group: Buy Nothing Norwood/Payneham/Kensington/Dulwich, SA.

**TREE PROTECTION LAWS - WORST IN AUSTRALIA**

It has been said that “the world is run by those who show up”. This statement came to mind when I decided to run for Council, volunteer for committees and write this article. Tree protection featured in the media recently and is my topic today. Whilst media coverage is great, I get frustrated when reporting gets my energy flowing but fails to include information about what I can do to help.

Thanks to Tom Morrison, Mitcham’s Young Citizen of the Year and founder of the Facebook Group 20 Metre Trees, we have the data that proves greater Adelaide has the worst tree protection laws in Australia. Why? Back in 2011 the state government passed regulations that allowed more trees to be chopped down to get around protections for significant and regulated trees. Why? Because the world is run by those who show up – in this case probably the property developers who want more land for urban infill.

The regulations allow property owners to chop down most trees within 10 metres of a dwelling or inground pool and to prune up to 30% of protected tree canopy.

In his extensive research, Tom found that there is an astounding disparity between our tree protections and those of most other jurisdictions. South Australia only uses tree circumference as a measure to protect trees (those with a two metre circumference at one metre above the ground). This is very weak compared with other dry urban areas in Victoria and NSW, that protect much smaller trees and also include canopy and height as factors. We don’t protect trees based on canopy, even though the 30 year plan for greater Adelaide has tree canopy goals. Interestingly, stronger protection laws interstate are not preventing development, they encourage better development.

So now that your energy is sparked, here’s what you do. Write letters requesting change to our local MP Premier Marshall, plus the other candidates for our electorate of Dunstan. Pen a letter to the editor. Start a petition. Volunteer for the campaign at [conservation.sa.org.au](http://conservation.sa.org.au).

Help run the world by showing up.

## HISTORIC KENSINGTON

### Rising Sun Inn – 60 Bridge Street



The State Heritage listed Rising Sun Inn was built in 1848 as an ale house with a 'tap room' run by William Beck. Beck had been in the 'service' (part of the African slave trade) of a Dr Edward Irving in America and had travelled to England with him. He married an Irish girl named Sarah Cullen. Known in the village as 'Black Beck' in 1849 he pioneered the first means of public transport between Kensington and Adelaide. Beck's spring cart made a round trip charging six pence each way. In 1868, brewer Sir Edwin Smith bought the inn and added a handsome bluestone façade and parapet. The inn closed its doors in 1883 when Smith transferred the license to his new establishment at the corner of High & Bridge St. The old inn became a private residence. In 1951, R.P. Tilbrook manufactured the only locally made South Australian motor cycles from here. In 1983, the building was restored and traded once more as an historic inn.

Legend has it that there was a murder in the cellar and that to this day there is an eerie presence near the cellar. The original line of the inn and wall can be viewed from the side of the building.

## RECENT GRANT SUCCESS

KRA committee members have successfully secured some welcome funding from several sources recently.

James Stevens MP, Federal Member for Sturt advised that KRA have received funding under the 2021/2022 Volunteer Grants Program, which will be spent on gardening tools and a defibrillator to be installed in Borthwick Park for park users to access during heart attack emergencies.

Green Adelaide Core Needs funding will be used to purchase a battery-operated blower for volunteers to keep Borthwick Park tidy.

Funding from the Norwood Payneham and St Peters Council Community Grants Scheme will be used to stage a Community Movie Night on April 9th outdoors in the park between Phillips St and High St, adjacent to High Street Café and the Kensington Pool. It'll be a great night, put it in your diary!

In addition, the Council have agreed to connect electricity to the tool shed in Borthwick Park to power the defibrillator and charge battery operated tools.

Adelaide is losing its mature trees at an alarming rate. According to a recent analysis, as many as 75,000 trees are being lost each year across metropolitan Adelaide. Recent changes to our planning rules are escalating the losses.

## HERITAGE AND PLANNING UPDATE

In April 2020, a 14,000 signature Petition was presented to the Legislative Council by Hon Mark Parnell MLC on behalf of the Protect our Heritage Alliance. The Petition raised concerns about the content and implementation of the Planning Development and Infrastructure Act (PDI Act) and the Planning and Design Code (Code) and requested independent reviews of their impacts, public accountability, risk assessment and governance.

The Legislative Review Committee (LRC) released its report in November 2021. It was critical of almost every aspect of the Code and made 14 strong recommendations for regulatory and legislative change.

The major recommendations were:

- Improved public engagement processes in proposed revisions and changes in the Code.
- Amendments to the PDI Act to require an annual independent risk assessment to be monitored by the Environment, Resources and Development Committee (ERDC).
- An independent review by an Expert Panel or the ERDC of the impacts on planning policies, community rights, sustainability and the environment of the PDI Act and the Code.
- A parliamentary committee to enquire into the anomalous use of the Planning and Development (Open Space) Fund to support the implementation of the Code and its ePlanning system.
- Further, that the PDI Act be amended to restrict the use of the Planning and Development Fund and the Urban Tree Canopy Off-set Fund to creating and developing open and green space.
- Prioritised implementation of each of the recommendations of the ERDC Inquiry into Heritage Reform (2019).
- That the current Heritage Reform Advisory Panel: increase local Council input; review and advise on the impact of the Code on demolition controls for heritage assets; and examine whether the Code affords adequate protection for 'Representative Buildings' and neighbourhood character.
- That the Statutory Authorities Review Committee enquire into the governance of the State Planning Commission and the State Commission Assessment Panel.

There was a minority report by SA Best recommending that donations from property developers to political parties be banned, as they are in Queensland and New South Wales. This issue must be addressed despite the failure of our two main political parties to support a ban!

The Government and the Parliament must now respond to the substantive findings of the LRC and correct the many damaging flaws and anomalies in the new planning processes.

### What can I do?

In the lead up to the March State Election, residents are urged to contact our politicians urging and seeking their support for real reform including banning developer donations. The Association can provide you with contact details for our MPs.

## MY KENSINGTON

I moved to Kensington in 2002, when I purchased my house from my late uncle's estate. However, my family has been part of Kensington for over one-hundred years.

My great grandparents, together with their two small children, Godfrey and Bertha, moved to Bishops Place in 1919. Some years later Bertha married in St Matthews church and moved to Kensington Gardens.

During the Second World War, Bertha's husband served in Papua New Guinea. At this time, Bertha and her two young children, moved back to her grandparents' home in Kensington. My mother, the younger of the two children, loved living with her grandparents and has told me many stories of life growing up in Kensington.

After my grandparents passed away, my uncle (who never married) inherited their house. Shortly after, the property was acquired and became part of the Marryatville Primary School grounds - where the tennis courts are now. My uncle then purchased a home on Shipsters Road and this is where I live now.

My deep family connection to Kensington is through my grandmother Bertha who never lived far from where I live today.

For me, living in Kensington connects me to memories of time spent with my grandmother and the stories she would tell of her childhood home, the people, the things that happened - the local history of Kensington. My grandmother loved telling these stories. Kensington is where she started her life and where she lived out her days.

My family has a rich connection to Kensington. One that continues today.
